	Please Note:	
	As per the WTA General Conditions of Entry Section 7.2. When you enter MySideline to register for your first	
	competition, you will be prompted to pay a national membership fee of \$22.00. Once you have paid your annua membership, you can register for as many competitions as you would like that year. A year commences 1 July	
	through to 30 June.	
	This is just a reminder for players that there is a late fee from when team nominations close until Round Five (5)	
	including 100% of the registration fee plus a \$20.00 late registration fee.	

F Duty Referee.

All teams are required to provide a duty referee when rostered. The team-nominated duty referee or duty referees will be appointed one (1) game per rostered duty team. (WTA suggest a team should have two (2) duty referees attend to share the game).

Duty teams will be paid \$30 per game and will be paid at the end of the season.

Failure to supply a duty referee will result in the following: -

- 1. If the team wins that match when rostered on for duty, they will lose four (4) competition points.
- 2. If the team loses that match when rostered on for duty, they will lose two (2) competition points.

Teams that fail to supply a duty referee may also face further action as determined by the WTA Board.
