	As per the WTA General Conditions of Entry Section 7.2. When you enter MySideline to register for your first competition, you will be prompted to pay a national membership fee of \$22.00. Once you have paid your annu		
	membership, you can register for as many competitions as you would like that year. A year commences 1 July		
	through to 30 June.		
	This is just a reminder for players that there is a late for from when terms a minimized along with Down I first		
	This is just a reminder for players that there is a late fee from when team nominations close until Round Five (5 including 100% of the registration fee plus a \$20.00 late registration fee.		

F	Duty Referee.	
	 Men's Open teams are required to provide a Duty Referee when rostered. Pending the nomination of teams, the Women's Open Teams will be asked to supply a duty referee next. The team-nominated duty referee or duty referees will be appointed one (1) game per rostered duty team. (WTA suggest a team should have two (2) duty referees attend to share the game). Duty teams will be paid \$30 per game and will be paid at the end of the season. 	
	 Failure to supply a duty referee will result in the following: - 1. If the team wins that match when rostered on for duty, they will lose four (4) competition points. 2. If the team loses that match when rostered on for duty, they will lose two (2) competition points. 	
	Teams that fail to supply a duty referee may also face further action as determined by the WTA Board.
