	This is a social competition for men 35 years and over. It has modified rules – seven (7) a side, with the acting half not allowed to run. There will be three (3) pools within this competition.		
	Thirteen (13) round competition with a three (3) week finals series.		
С	Player Eligibility.		
	All conditions of player eligibility must be followed as outlined in the WTA General Conditions of Entry, Section 5.		
	WTA General Conditions of Entry Section 5.2.2.1. Players must be born in 1990 or before. (35 years or older). (For competitions commencing in 2025).		
D	Team Registration. All conditions of entry must be followed as outlined in the WTA General Conditions of Entry, Section 6. The link to register your team in your chosen competition can be found HERE. The team coordinator/manager is reminded to have a minimum of ten (10) players registered as per WTA General Conditions of Entry Section 6.1.3.		
E	Player Registration, Membership and Competition Fees.		
	All player registration conditions must be followed as per the WTA General Conditions of Entry, Section 7.

F Duty Referee.

All teams are required to nominate and provide a duty referee when rostered. The team-nominated duty referee or duty referees will be appointed for one (1) game per rostered duty team. (WTA suggest a team should have two (2) duty referees attend to share the game).

Duty referees will be paid \$30 per game and will receive payment on the night of the game they referee.

Failure to supply a duty referee will result in the following: -

- 1. If the team wins that match when rostered on for duty, they will lose four (4) competition points.
- 2. If the team loses that match when rostered on for duty, they will lose two (2) competition points.

Teams that fail to supply a duty referee may also face further action as determined by the WTA Board.
