G	Duty Referee.	
	All teams are required to nominate and provide a duty referee when rostered. The team-nominated duty referee or duty referees will be appointed for one (1) game per rostered duty team. (WTA suggest a team should have two (2) duty referees attend to share the game).	
	Duty referees will be paid \$30 per game and will receive payment on the night of the game they referee.	
	Failure to supply a duty referee will result in a \$50 fine and the following: -	
	 If the team wins that match when rostered on for duty, they will lose four (4) competition points. If the team loses that match when rostered on for duty, they will lose two (2) competition points. 	
	Teams that fail to supply a duty referee may also face further action as determined by the WTA Board.	
Н	Draw Matches.	
	All matches will need a result. If a match is drawn at full time, a drop-off will be played to decide the winner.
