	The person appointed by the team to referee when rostered and act on behalf of the team. Responsible for liaising with WTA relating to the team's referees and the competition they have entered.

	A team is a group of players participating in Touch Football registered in the Wagga Touch Association (WTA).	
J	Team Coordinator/Team Manager	
	The person appointed by the team to act on behalf of the team. Responsible for liaising with WTA about the team and the competition they have entered.	
	It is recognised that the Team Coordinator has the team's delegated authority and can make decisions, including financial ones, without consultation.	
K	Volunteers	
	Regardless of their affiliation with the Wagga Touch Association, individuals who willingly offer their time and effort to help organise and execute a competition are called volunteers. Furthermore, they are acknowledged as officials of said competition.	
L	Doping Policy	
	The WTA Doping policy, adopted by the TFA Board of Management (BOM), governs TFA's position on all doping practice matters.	
М	Member Protection Policy	
	The WTA Board endorses the use of the TFA Member Protection Policy. It relates to WTA's position on all behavioural matters of participants at WTA-controlled competitions. It is listed under the General Conditions of Entry and the respective Conditions of Entry for each competition.	
М	20 Years and Under Player	
	Players aged 20 years or younger at the start of the competition are eligible to participate in an under-20 competition.	
0	Open's Player	
	Players aged 13 years or older in the year the competition commences are eligible to participate in a senior competition.

	SECTION 2: AGREEMENTS
2.1	Agreements to enter Wagga Touch Association competitions
2.1.1	Abide by the WTA General Conditions of Entry, each relevant competition's Conditions of Entry documents and all WTA policies and by-laws.
2.1.2	Meet their financial obligation to the WTA, both as a Player/Team and for the competition entered, within the timelines outlined in the competition's Conditions of Entry.
2.1.3	Market the sport of Touch Football professionally and allow WTA to use the Affiliate's brand and reputation.
2.1.4	Attend all WTA functions where required. Non-attendance by mutual consent is acceptable.
2.1.5	Complete all competitive requirements of the WTA competition entered, including all finals and playoff matches, as outlined in the Conditions of Entry.
2.1.6	Ensure that all compliance matters required under the WTA Team Regulations have been met prior to entry into the competition.
2.1.7	Comply with any requirement outlined in the General Conditions or the Conditions of Entry documents for the provision of officials for the competitions entered.
2.1.8	Failure to comply with Clause 2.1.2 will result in the Team's inability to participate further in WTA competitions until all financial requirements are fulfilled.
2.1.9	Abide by any addendum or changes to competition conditions as applied by WTA due to changes in Public Health Orders.

	SECTION 3: RESPONSIBILITIES
3.1	Players Responsibilities
3.1.1	Abide by the WTA General Conditions of Entry, each relevant competition Conditions of Entry document and all WTA policies and by-laws.
3.1.2	Complete a Membership and Participant Declaration through the WTA online player registration process.
3.1.3	Always play to the best of your ability.
3.1.4	Always behave in a manner that does not bring WTA, the Team, or the Sport into disrepute as per WTA's constitution and Member Protection Policy. Failure to comply with this clause may result in the player being subject to a penalty.
3.1.5	Be available at all reasonable times for media and promotional purposes as requested by WTA.
3.1.6	If required to attend a function or media request related to WTA duties, they are to wear the official uniforms supplied by the Affiliate, NSWTA, and/or TFA, as requested by WTA.
3.1.7	Attend all WTA meetings/judiciary/disciplinary hearing requests as required.
3.1.8	Abide by the Member Protection Policy and NSW Touch Social Media Policy as outlined in the General Conditions document.
3.1.9	To make themselves available as a first choice for WTA teams and NSWTA Regions. Failure to do so will deem the player ineligible for player status.
3.2	Team Responsibilities
3.2.1	To gain entry to a WTA competition, teams must respond within the required timelines as outlined in the Conditions of Entry for the competition they wish to nominate and comply with all the necessary requirements.
3.2.2	Ensure that all financial responsibilities related to registration fees for competition entry have been met.
3.2.3	Appointment of Team Coordinator and Duty Referee for the competitions entered. The Team Coordinator will be the primary liaison between the team and WTA in all matters, including refereeing duties.
3.2.4	Communication Each Team Coordinator MUST fill out the Google doc when entering a team. The link will be provided in each Competition's Conditions of Entry. All correspondence during the tournament will be sent out via the nominated email addresses. It is the responsibility of the Team Coordinator to ensure that all provided email addresses are free from spelling errors. A request for a decision or ruling should be submitted in writing to the WTA.
3.2.5	Ensure that team players and Officials have been instructed on the Member Protection Policy and are aware of their responsibilities. Failure of the Team to comply with this clause may result in the Team being subject to a penalty.
3.2.6	Behave always in a manner that does not bring the WTA/Sport into disrepute.
3.2.7	Attend all relevant WTA meetings, judiciaries, disciplinary hearings, functions and media calls as required.

3.3.1	Plan and develop the Local Competitions Calendar, including leading and administering each WTA competition.		
3.3.2	Promote Touch Football to their local community. Maintain a community-engaging domestic social touch football competition open to all potential participants. Regularly undertake activities to grow the said competition while upholding a high reputation and integrity.		
3.3.3	To run a minimum of one (1) referee accreditation course per annum.		
3.3.4	Ensure that all referees, coaches, and officials have undertaken and achieved the minimum accreditation level requirements for the competition they are entering, for their entry to be accepted.		
	Determine policy regarding financial matters affecting the competition, including:		
3.3.5	a. Centrally controlling income such as TV revenue, Major Corporate sponsors, naming rights, licensing, and sponsorship.b. Any penalty is to be imposed on the team.		
3.3.6	Liaise with Wagga Wagga City Council, the governing body responsible for maintaining Jubilee Park, to ensure a standard playing surface, field markings, and facilities meet the requirements for WTA competitions.		
3.3.7	Establish the systems for determining the winners at the end of the WTA competitions.		
3.3.8	Keep teams and players informed about current trends and relevant information. Develop a process for teams and players to express their concerns and comments on any matter. The WTA must quantify its request for a decision or ruling in writing to the team or player.		
3.3.9	Establish an effective program to prevent the practice of "stacking" teams, ensuring a steady flow of players is available for all teams.		
3.3.10	Determine the judicial procedures of the WTA competitions.		
3.3.11	Abide by the Member Protection Policy and Social Media Policy.		
3.3.12	Ensure match results are updated on the WTA Competitions.		
3.4	Officials and Referees		
3.4.1	Abide by the WTA General Conditions of Entry, each relevant Conditions of Entry document and all WTA policies and by-laws.		
3.4.2	Officiate and always perform to the best of their ability.		
3.4.3	Always behave in a manner that does not bring WTA, the Team/Affiliate, or the Sport into disrepute as per WTA's constitution and Member Protection Policy. Failure to comply with this clause may cause the Official or Referee to be subject to a penalty.		
3.4.4	Actively enforce and educate players on the zero tolerance 'no backchat' policy towards referees.		
3.4.5	Be available at all reasonable times for media and promotional purposes as requested by their team, affiliate, or WTA.		
3.4.6	If required, when attending a function or media request related to WTA duties, wear the official uniforms supplied by the Team/Affiliate, WTA, NSWTA, and/or TFA as requested by WTA.		
3.4.7	Abide by the Member Protection Policy and Social Media Policy.		
3.4.8	All officials must have a minimum level of accreditation for the appointed position. Referees must wear the official referee uniform or a WTA-provided referee vest.

3.4.9	Enforce all competition-specific clauses outlined in the Conditions of Entry relating to games, including the Mutual Respect Policy and procedure.
3.4.10	Complete all reports within the required timeframes.
3.4.11	Attend all relevant WTA meetings, judiciaries, disciplinary hearings, functions and media calls as required.
3.4.12	For the Team Coordinator and/or Duty Referee to liaise and cooperate with the WTA Referees Director and WTA Events Team, including weekend and weekly event appointments.
3.4.13	Referees must be registered and participating with WTA for eligibility and insurance purposes and must regularly officiate at WTA in the current competition or a previous competition.

	SECTION 4: COMPETITION, POOL, DIVISIONS AND CATEGORIES
4.1	Wagga Touch Association Competitions
4.1.1	Please check the relevant "Conditions of Entry" for commencement dates, times and other relevant details.
4.1.2	Monday Night Men's 35 and Over Competition This is a social competition for men 35 years and over. It has modified rules – seven (7) a side, with the acting half not allowed to run. There will be three (3) pools within this competition. Tuesday Night Men's and Women's Open Competition. (Includes previously known youth league competition) This is an open competition for men and women. It is ideal for social players. Pending team nominations, the men may have three (3) graded pools and the women two (2) graded pools or more if required. Men's and Women's Premier League This is an open men's and women's competition for our elite players. This is WTA's showcase competition. Women's 30 and Over Competition This is a social competition for women 30 years and over. It has modified rules – seven (7) a side, with the acting half not allowed to run. If four (4) teams are not nominated in this competition, these teams will be moved into the lowest grade of women's open, but not in the competition that was formerly known as girls' youth league. Wednesday Night Mixed Open Competition. This competition is a mixed competition. With teams nominating in either a 6 pm or 7 pm time slot to play. Teams can nominate and play in 1 of 4 classifications - Open Age Family Team, Open Age Friends and Work Team, Under 20's and Over 30's Thursday Night Junior Competition. This competition is open to junior boys and girls in the following age categories: Under 8, Under 10, Under 12, and Under 14. Depending on the number of teams, there may be pools within each age group. DAY AND TIME TO BE ADVISED Junior Mixed Commetition. (Commencing Early 2026)
	Junior Mixed Competition. (Commencing Early 2026) This competition is open to junior boys and girls in the following age categories: Under 8, Under 10, Under 12, and Under 14. Depending on the number of teams, there may be pools within each age group.

	SECTION 6: TEAM REGISTRATION
6.1.1	WTA uses the online team registration process via MySideline for all competitions. This online registration process is provided through MySideline and is accessible until the closing registration date. After this time, no further registrations may be taken. This is up to the discretion of the WTA Tournament Director.

6.1.4	Once the online registration process is completed, a registration sheet will be developed and then emailed or handed to the team coordinator/team manager by Round 3. It is the team coordinator/team manager's responsibility to ensure that all details are correct. The team coordinator/team manager will need to sign it to verify its accuracy and hand it to a WTA representative upstairs in the clubrooms by Round 4.
6.1.5	A team sign-on sheet may be provided for team members to fill out with their playing numbers correctly. It is to be signed by all team members on game day. No player is to take the field until they have signed the signon sheet. Teams found breaching this condition of entry will automatically forfeit all games until this process is completed.

9.1.3	Any individual wishing to withdraw from a team is eligible for a refund of player registration fees, less any fees incurred via online Registration and an administration fee of \$20.00 inc GST. Banking details will need to be supplied. Refunds, less fees, will be processed within 21 days of being notified of the individual's withdrawal.
9.1.4	Any individual completing their player registration online past the competition's advertised registration closing date will incur a Late Registration Fee of \$20.00 inc GST.

Deferred Match
Any team that has 3 or more players away at a representative touch tournament or at a training session for that tournament are entitled to defer any games scheduled during the period of that tournament or training session. The period includes travel to and from the tournament or training session.
Games deferred due to representative touch football commitments must be played at a reasonable time that is convenient to the opposing team. If the teams are unable to agree on a time and date, WTA will determine when the game is to be played.
If a team wishes to defer a game due to touch football representative commitments, you must email contact@waggatouch.com.au no later than one (1) week before the scheduled game.
If a team wishes to defer for other reasons, it can only do so with the opposition's agreement. The opposing team would then have to agree on an appropriate time and date for the game to be played. If you wish to do this, you must email contact@waggatouch.com.au no later than two (2) weeks before the scheduled game.
If an agreement cannot be reached, the game will be deemed as a forfeit to the team wishing to defer.
The team that requests that a game be deferred must notify the Tournament Director via email at contact@waggatouch.com.au of the new scheduled match. The match must be played as soon as possible from the originally scheduled game or before the final series commences. Failure to play the game before the finals series commences, if a team deferred because of representative commitments, this match is declared a draw; if a team deferred because of other reasons, the team wanting to defer will record a loss. The Tournament Director or their nominated representative must attend the match as the official timekeeper and WTA Representative. It is also the Tournament Director, with advice from the Referees Director, to appoint referees for all deferred matches.

Delay of Match & Forfeits
Teams must be at their playing fields five (5) minutes before the commencement of their match.
It is the responsibility of each captain to report to the referee so that the toss of the coin can be affected without loss of time. If a team is not at the field at the advertised starting time of the game, the attending team can be awarded the winning of the toss.
The referees will be positioned on the field for five (5) minutes.
The offending team will receive a maximum of five (5) minutes from the commencement of the game (siren/whistle) to position the team on the field and be ready to commence play.
If the offending team is not in attendance after the five (5) minutes have expired, the game will be deemed a forfeit, and the non-offending team will be awarded a 5 - 0 win and receive competition points to the value of a win being three (3) points. The offending team will receive a score of 0 - 5 and receive a penalty of minus two (-2) competition points. The offending team will be penalised one (1) Try after the first (1) minute and one (1) Try every minute thereafter up to a maximum of five (5) minutes. The time will be judged from the commencement of the game (siren/whistle) to the time when both teams are ready to commence play.

10.15 Blood Bin

10.15.1

Any player with a bleeding cut or abrasion is to leave the field immediately and have the cut or abrasion cleaned and covered. At this time, any blood-stained clothing must also be either cleaned or replaced.

If the player does not leave the field immediately, the Referee will stop the game and ask the player to leave the field (normal substitution rules apply).

Once the flow of blood has been stemmed, the cut or abrasion cleaned and covered, and any blood-stained clothing and equipment cleaned or replaced, the player may return to the field and continue play.

	If bleeding cannot be controlled and the wound is not securely covered, the player must stop playing the game.
10.16	Injuries
10.16.1	Any injury that occurs during the game MUST be reported by a Coach, Manager, or Team Member after the game to the WTA clubrooms to ensure that the necessary forms are completed. WTA reserves the right to call an ambulance if deemed necessary.
10.17	Force Majeure
10.17.1	 a) If WTA is unable to perform, in whole or part, any obligation under these regulations of a Force Majeure Competition, WTA is relieved of that obligation under these regulations to the extent and the period it is unable to perform. b) In addition, WTA is not obligated to refund any fees paid to any individual or team if it is unable to perform due to a force majeure event. FORCE MAJEURE COMPETITION: for the purposes of these regulations, a force majeure event includes but is not limited to any or all of the following: Natural disasters, including floods, droughts, earthquakes, storms, cyclones, fires, explosions, epidemics, pandemics, or War or Act of Terrorism, or Riot or civil disturbances, or Permanent injunction of any duly constituted court of competent jurisdiction or Any fact, circumstance, matter or thing beyond the reasonable control of WTA.
10.18	Weather
10.18.1	Rescheduling of Rounds or Matches affected by weather may be moved to the next available timeslots, fields, or rounds (where practical). WTA reserves the right to organise the affected games in whatever format will assist them in occurring in as equal conditions as possible. Rescheduling of Matches If, due to any other extraordinary circumstances, a game cannot be completed to full time, the game may be rescheduled as soon as possible at a time and on a ground arranged by the Tournament Director in consultation with both Teams. If the game has commenced and cannot continue to 50% completion, the following will apply: a. The game will start from the beginning and must be completed full-time up to the regulation. b. The score will commence at 0-0. For any game that is completed 50% of the time or more, the score at that time will be deemed to be the result. If, due to time constraints or any other reason, a game cannot be rescheduled, the following will occur: 1. Games that did not continue to 50% completion will be abandoned, and a 0-0 score will result. When any type of weather affects a finals series, where games need to be cancelled or cannot be replayed at a later date, the team higher on the ladder will be deemed the winner.
10.18.2	Hot Weather Policy In the event that games need to be rescheduled due to extremely hot weather, please refer to Clause 10.18.1. Games will not commence if the temperature exceeds 38 degrees; they will be postponed until the temperature decreases.

If the temperature reaches 36 degrees, any games underway will be completed, and any subsequent games will be played as halves, thirds, or quarters with a two (2) minute break between periods.

WTA will return to the regular format, guided by a drop in temperature back below 36 degrees. The Bureau of Meteorology will be used as a guide.

Cold Weather Policy

In the event that games need to be rescheduled due to extremely cold weather, please refer to Clause 10.18.1.

Local weather reports will be monitored when severe weather is forecast. If the temperature drops below 8 degrees and the ground is deemed excessively slippery from frost, snow, rain, or mud, the WTA will determine whether play should be suspended or postponed until the conditions improve.

11.1	Playing Rules
	WTA conducts competitions under the <u>Touch Football Australia 8th Edition rule book</u> .
11.1.1	WTA also includes variations of these rules, called Special Playing Rules, in the "General Conditions of Entry" and the "Competition Conditions of Entry."
11.2	Substitution and Interchange Area – (Except Under 8's and Under 10's)
11.2.1	All interchanges must occur at or within the team's interchange area and only after the substituted player has crossed the boundaries and entered the Interchange area. All interchanges must be made on one side of the field and without delay. Physical contact is not necessary between interchanging players. Players leaving or entering the field shall not hinder or obstruct play and must enter from an onside position. Following the scoring of a Try whilst the play is dead, players may interchange at will without having to wait for the substituted player to enter the interchange area.
	RULING (Rule 17) - A Penalty to the non-offending Team at the point of the Infringement.
11.2.2	The only personnel allowed in the interchange will be the fourteen (14) registered players plus four (4) team management officials nominated. That is a maximum of eighteen (18) people (this includes those players participating on the field). N.B Any player found to have left the sub box to become involved in a melee, brawl or fight may be dealt with in the following way. If, in the referee's view, a player/s or official/s leaving the sub box engages in illegal play that would, under the normal circumstances of general gameplay, warrant being sent off, they should do so. This will incur a minimum four (4) match suspension on top of any further suspension handed down by the judiciary. If, in the referees' view, a player/s or official/s leaving the sub box engages in activities that would not under the normal circumstance of general gameplay warrant being sent off, they should: • Record the number of the player(s) leaving the sub box to become involved in a melee, brawl or fight. • Advise the captain that they will report those players to WTA. • File a report at the end of the game noting those players for the WTA to take action. The action of leaving the sub box to become involved in a melee, brawl or fight will be an automatic four (4) match suspension.
11.3	Players, Coach and Referee Communication- Mutual Respect Policy
11.3.1	All members, whether Referees, Coaches, Players, Office Bearers, and/or spectators, have an obligation to be conversant with this protocol and the WTA, NSWTA, and TFA member Protection Policies. Please refer to the Mutual Respect Policy.
11.3.2	Referees are instructed not to engage with players, coaches, managers, or officials, to walk away from any possible confrontation, and to report it to the WTA.
11.3.3	Disputes of the score must be raised in writing with the Tournament Director.
11.3.4	All players need to be advised that Playing Rule 20, Misconduct, will remain in force. Referees have been instructed not to tolerate abusive behaviour in the Interchange Area during the game and to deal with it appropriately by removing a player from the field if it occurs.
11.3.5	Players, coaches, managers, or officials may not agree with the way a referee officiates a game or with decisions made; however, there are proper procedures and avenues to handle such matters. Approaching referees after the game is not the measure we allow. We do, however, welcome feedback, reports, or consultation under the proper guidelines.

	Should you have an issue with the performance of a referee, you may: • Contact either the Tournament Director or the Director of Referees.
	If necessary, they will orchestrate a meeting with the referee, coach and panel member.
	Disputes or feedback are to be placed in writing and forwarded to the Tournament Director.
11.3.6	Breaches of the Mutual Respect Policy may incur a suspension, which will be imposed under the competition's control. Further, they may find themselves summoned to attend a judiciary, whereby the penalties may be imposed.
	Coaching Positions The only people allowed behind the deadball line are the Coach, Assistant Coach, or Manager. A Coach may position themselves at the end of a field. If they are at the end of the field, they must remain at least five metres behind the deadball line. Any Coaching/Management staff at the end of a playing field cannot issue any verbal or physical commands
11.3.7	directly to the team they are observing and can only communicate to the team or other coaching/management staff in the interchange area by returning to the interchange area or by use of electronic communication equipment. Any person found to be disregarding this tournament rule will be asked to return to the interchange area. Coaches are reminded that they are under the jurisdiction of the Tournament Conditions, WTA Officials and the referees, regardless of whether they are in the interchange area or at the end of the field.
	Failure to comply with this will result in individuals being asked to leave the venue for the duration of the game and may result in further action.
11.4	Captain Bands
11.4.1	WTA is continuing its "zero tolerance" system regarding referees this season to ensure we keep Referees engaged in our game.
11.4.2	Each team will be given an armband, which one player (the captain) will wear throughout the game.
11.4.3	Only the player (the captain) with the armband will be allowed to speak to the Referee, and this must be done with respect.
11.4.4	If other players distract the Referees by providing the referee with their opinion, speaking to them unnecessarily, questioning calls, etc., the player will automatically be penalised and sent to "the bin".
11.5	Send Offs
11.5.1	Any player sent from the field for the remainder of the game will receive an automatic two (2) match suspension unless the Judiciary or Disciplinary Committee considers further action.
11.5.2	Matches not played or cancelled due to weather will NOT be included in that suspension.
11.6	Sin Bins
11.6.1	Players who receive two "sin bins" throughout the competition will receive an Automatic one (1) match suspension. Every subsequent sin bin will receive an automatic one (1) match suspension.
11.6.2	A one (1) or two (2) match suspension is to be served on the following: - one (1) or two (2) games in which the team is scheduled to play. - Byes do not count as a game played. - A team that wins by a forfeit will count; however, a team losing by a forfeit will not.
11.6.3	A sin bin applied to a player for a team offence will not be registered against an individual.

	SECTION 12: PROTEST, DISPUTES AND DISCIPLINE
	Protest and dispute matters will be heard and determined by either the Tournament Director or if required,
	the WTA Judiciary Panel appointed by the WTA officials.
12.1.1	Judicial matters will be handled via the WTA Disciplinary Policy. Hearings will be held in accordance with the TFA Disciplinary Regulations.
12.1.2	Protests and/or disputes must be lodged in writing to the WTA Tournament Director within 24 hours of the conclusion of the competition.
12.1.3	Protest is to be lodged via email and signed by the team coordinator.
	WTA's delegated authority will then investigate protests, and their decision will be returned to the team coordinator.
12.1.4	Any notice to any person to attend a hearing must be served on the team coordinator, and such service is deemed to be served on all parties or persons under the team coordinator's control.
12.1.5	 WTA reminds all parties that the following issues will not be open to appeal and/or protest and, therefore, formally advises all teams that they must be aware of this prior to the commencement of games: The Referee is the sole judge on all match-related matters inside the field perimeter for the duration of a match, and they have jurisdiction over all players, coaches, and officials. A team found playing an unregistered player will be penalised if they win the match, four (4) competition points and if they lose the match, two (2) competition points.
	If a team does not agree with the score on the scorecard, they are to lodge a protest.
12.1.6	The following information is to be provided with the protest: • Who tapped off • The order the scoring occurred (including player numbers of both teams) • The half-time and full-time score
	The opposing team will be contacted to verify the score. If they do not agree or in the event of inconclusive evidence, the score will be recorded as the score that the Referees have recorded.
	Alternatively, video evidence can be provided, and the evidence will be used if conclusive.
12.1.7	Players sent from the field for the remainder of the game will be dealt with via the WTA Disciplinary Policy and may be required to appear before a WTA Judiciary or Disciplinary Hearing. The WTA Disciplinary Policy and Procedures allow for the individual to accept the penalty early rather than appear before a Judiciary Hearing.
12.1.8	Any Player, Official or other Member of a Team/Affiliate who is the subject of a complaint or report may be dealt with via the WTA Disciplinary Policy and may be required to appear before a WTA Judiciary or Disciplinary Hearing.
12.1.9	Disciplinary Hearings will be conducted at the earliest possible convenience after the provision of the report is handed to the team coordinator, who will be responsible for passing the paperwork on to the player concerned.
	If a complaint or report is submitted about a player, official, or other member, the WTA official will contact the team coordinator, who will be issued a Notice of Hearing outlining the details of the Disciplinary Hearing and a copy of the written complaint or report.
	Judiciary hearings within WTA will take place on Thursday nights from 7:00 pm.
12.1.11	WTA has adopted <u>Touch Football Australia (TFA) Code of Conduct</u> and the <u>New South Wales Touch</u> <u>Association (NSWTA) Social Media Policy</u> . Players, teams, officials, guardians, and spectators must

	abide by these codes, which can be found by clicking on the above links. If a Wagga Touch Representative suspects anyone of breaching these codes, they may be asked to leave the Touch Fields. Failure to do so will result in the game being stopped or cancelled until the offending person complies.

	SECTION 13: UNIFORMS
13.1	Quality
13.1.1	All teams playing uniforms are to be correctly numbered, have the same design and artwork, and be correctly worn for all games of the competition. Approved Touch Football shoes must be worn in accordance with Rule 3.2 of the TFA rulebook. N.B. Uniform designs that clash with the Referee Uniform will NOT be allowed (to avoid confusion with the Referee).
	Ideally, WTA would like to see our logo on the right-hand side of the chest. The WTA logo can be found by clicking on this <u>LINK</u> .
	Official playing uniform items are determined as (but not limited to): • Playing Shirt or Singlet. • Playing Shorts or Tights. • Socks.
	All playing uniforms must include the following: • Identification numbers: All players are to wear an identifying number on the back of their shirt/singlet. • No temporary measures, such as tape, will be permitted to replace or amend numbers. • A one or two-digit number that meets the requirements set out above. • The only playing numbers permissible are from 1 to 16 inclusive.
13.1.2	If any Player, Coach, Manager, or Official from a team is observed by a Tournament Official or by the Tournament Director and deemed to be NOT in the team's correct uniform whilst playing, this player will be requested to leave the field of play and cannot return until they are in the correct team uniform.
	The penalty for any Player, Coach, Manager, or Official taking the field of play in the incorrect team uniform, the offending team will forfeit that round's game.
13.1.3	Teams are to be correctly attired by Round 4. If teams are having supplier issues, please communicate this before the start of Round 5. Please email contact@waggatouch.com.au

	SECTION 14: SPONSORSHIP AND LOGO DISPLAY			
14.1	Affiliate Uniforms			
14.1.1	All logos and sponsor names on uniforms or dress gear must be of a size, quality, and design standard acceptable under the NSWTA Uniform Guidelines.			
14.2	Other Usage of Logos & Banners			
14.2.1	Usage of the WTA and WTA Sponsors is encouraged; however, authorisation of any usage must be obtained from WTA. Any public display of an Affiliates Sponsors logo and or their partners must receive express permission from			
	the WTA prior to the competition. Penalty: \$500 maximum per breach.			
	N.B Sponsors and or partners that directly conflict with WTA partners at WTA competitions will not be granted display permissions.			
	SECTION 15: IMAGES			
15.1.1	All persons accept that by participating in their selected competition, they may be photographed/filmed and that these images may be used by the WTA for the promotion of the sport. The WTA will not pass any image/s onto a third party unless prior approval is sought. If you do not wish the WTA to be able to use your image/s or be filmed, you must notify the WTA in writing.			
15.1.2	WTA reserves the right to take immediate possession of any video footage taken at a WTA competition that may assist the WTA in investigating any matter of judiciary, discipline or protest. All care of equipment, tape, and data cards will be taken and returned to the owner upon a determination by the judiciary, disciplinary hearing, or protest.			
15.1.3	With the rise in the use of social media, WTA has regulations (adopted NSWTA policy) around the filming and or photography of players and games at competitions. To protect the privacy and images, anyone filming and photographing games or players will be required to be registered with and be APPROVED by WTA to have permission to photograph or film. In allowing photography/videography, applicants must comply with relevant clauses and conditions set out by the WTA around the use of the footage/photos.			
	Teams must apply to the WTA prior to the competition for any official photographer/videographer and acknowledge, along with the approved applicant, that images/film MUST NOT be passed on to a third party unless prior approval is sought and granted.			
	Approved applicants must report to the Tournament Director prior to the commencement of the competition to be issued a WTA Official photographer vest and/or pass that must be worn or displayed at all times while engaged at the competition/event. Non-compliance will result in credentials and permissions being immediately removed.			

	SECTION 16: WORKING WITH CHILDREN
16.1	Working with Children Check (WWCC)
16.1.1	Working With Children Check (WWCC) is a legal requirement for persons who work or volunteer with children (under 18 years old). It checks the background of persons who work or volunteer with children in sports clubs, schools, childcare centres, community groups, Churches, and other organisations. All coaches and managers of teams with players under the age of 18 registered must have a WWCC and provide the WTA with the details accordingly.
16.2	Guardianship
16.2.1	In some instances, persons under the age of 18 will be in attendance at WTA competitions. In understanding our expectations around your role and responsibilities, we provide Teams with some additional information related to legal guardianship. This communication contains general advice only and does not take into account individual objectives, circumstances and or a legal view. Individual research and advice should be sorted according to your personal circumstances. Guardians - A guardianship is a legal right given to a person to be responsible for the food, health care, housing, and other necessities of a person deemed fully or partially incapable of providing these necessities for himself or herself. What Are a Guardian's Duties? The guardian makes decisions about how the person lives, including their residence, health care, food, and social activity. The guardian is intended to monitor the person and ensure that the person lives in the most appropriate, least restrictive environment possible, with appropriate food, clothing, social opportunities, and medical care. Communication with the Parents Ensure you are informed of any medical concerns, including food allergies. In addition, you'll need to agree on things like sleeping arrangements, the administration of over-the-counter medications, and procedures for contacting the parents in an emergency. 16.3	Supervision of Under Age Participants
16.3.1	Teams are responsible for the direct supervision of any player, official or referee who is under the age of 18 years old ("Minor"). Teams must take all reasonable steps to protect Minors under their supervision from all forms of harassment. This includes but is not limited to ensuring that: • Each Minor and their legal guardian are provided with a copy of the Member Protection Policy; • All Officials comply with all applicable Child Protection laws. All reasonable steps are taken to supervise Minors when travelling to, during, and from the Competition. The Team must appoint a guardian for each Minor whose parents and/or legal guardian are not in attendance. The appointment of such guardian must be approved in writing by the parents and/or legal guardians of the Minor prior to the Competition.

SECTION 17: BREACHES OF RESPONSIBILITY

In the event that a participant or team breaches any responsibility as set down in the General Conditions of Entry or the Conditions of Entry documents, that participant or team will be required to explain the Breach to a duly convened meeting of the Board or their representative, the Tournament Director.

In accordance with the WTA Constitution, the penalty that may be applied through the power hereby conferred may disqualify, suspend, fine or otherwise deal with any person or body they find to have been guilty of such Breach.

Any rule breach not mentioned in this document will be subject to a penalty as determined by the Board or their representative, the Tournament Director.

Any appeal against the determinations of the Board or their representative, the Tournament Director, must be lodged with an appeal fee of \$200.00. The fee will be refundable upon the appeal being upheld.

SECTION 18: DOPING POLICY

The WTA is under the TFA Doping Policy, which will be enforced at WTA competitions. The Australian Sports Anti-Doping Authority (ASADA) could randomly test any participant (in accordance with their policy). Any indiscretions found will incur the penalties as prescribed in the TFA Doping Policy. This information can be obtained from the TFA Website.

SECTION 19: POLICIES

Item 1: Member Protection Policies

17.1.1

Member Protection is a significant issue both within the community and within the sports environment. WTA has a moral responsibility to ensure we remain valid and current with Member Protection issues related to the members of WTA.

TFA and NSWTA have adopted an education process on the issue of 'Play by the Rules'. This program is available at www.playbytherules.net.au. It has several interactive courses that coaches and officials can take to learn more about Member Protection. Below is the statement from the home page of the Play by the Rules website.

"Play by the Rules" provides information and online learning about how to prevent and deal with discrimination, harassment and child abuse in the sport and recreation industry.

"Play by the Rules" is a partnership between the Australian Sports Commission and all State/Territory sport and recreation and anti-discrimination agencies. The information on Play by the Rules is not intended to be, nor should it be relied upon as, a substitute for legal or other professional advice."

WTA will encourage each official attending WTA competitions to complete the online course and supply their team with a certificate for completing the course. The course is relatively easy and informative and takes limited time to complete. The certificate should be submitted via email to contact@waggatouch.com.au. We hope that you find value in this initiative as we all work towards providing an environment that is both positive and safe for all participants.
