B	NSW Touch Football Limited (NSWTF)
	NSW Touch Football Limited (NSWTF) is the state governing body for Touch Football in New South Wales.
C	Touch Football Australia Limited (TFA)
	Touch Football Australia Limited (TFA) is the national governing body for the sport of Touch Football in Australia.
D	Wagga Touch Association Competition
	<p>The Wagga Touch Association (WTA) conducts several tournaments throughout the year. These are: -</p> <p>Monday Men 35 years and older.</p> <p>Tuesday Men's and Women's Open Competition (13 years and older, with options of Pool A, B and C which is a youth competition 13 -20 years old). Men's and Women's Premier League. (13 years and older) Women 30 years and older.</p> <p>Wednesday 20's Mixed, Open's Mixed and 30's Mixed. (13 years and older)</p> <p>Thursday Boys and Girls Junior Competition (Under 8's to 14's). (September - December) Mixed Junior Competition (Under 8's to 18's). (January - April)</p>
E	Wagga Touch Association Tournament Director
	<p>The WTA Tournament Director administers the General Conditions of Entry, Conditions of Entry for the relevant Competitions, Playing Rules, and Special Playing Rules.</p> <p>Changes may also be made at any time by the Tournament Director and will be communicated to the appropriate parties as soon as possible for any updates to the General Conditions of Entry, the Conditions of Entry for the relevant Competitions, the Playing Rules, and the Special Playing Rules.</p>
F	Wagga Touch Association Board
	<p>The WTA Board serves as the governing body for Touch Football in Wagga Wagga, NSW.</p> <p>The WTA Board have approved the following: -</p> <p>General Conditions of Entry, Conditions of Entry for the relevant Competitions, Playing Rules Special Playing Rules.</p> <p>The WTA Tournament Director is responsible for liaising with the WTA Board on the above conditions and rules, recommending improvements, and interpreting any conditions and regulations outlined in the above documents.</p>

G	Officials
	Individuals who hold positions of responsibility in a WTA competition include Referees, Coaches, Assistant Coaches, Team Managers, Assistant Team Managers, Sports Trainers, Physiotherapists, Doctors, and Association Administrators.
H	Duty Referees
	The person appointed by the team to referee on the team's behalf when rostered, and acts on behalf of the team. Responsible for liaising with WTA relating to the team's referees and the competition they have entered.
I	Team
	A team is a group of players participating in Touch Football who are registered with the Wagga Touch Association (WTA).
J	Team Coordinator/Team Manager
	The person appointed by the team to act on behalf of the team. Responsible for liaising with WTA about the team and the competition they have entered. It is recognised that the Team Coordinator/Team Manager has the team's delegated authority and can make decisions, including financial ones, without consultation.
K	Volunteers
	Regardless of their affiliation with the Wagga Touch Association, individuals who willingly offer their time and effort to help organise and execute a competition are called volunteers. Furthermore, they are acknowledged as officials of said competition.
L	Doping Policy
	The WTA Doping policy, adopted by the TFA Board of Management (BOM), governs TFA's position on all doping practice matters.
M	Touch Football Australia Member Protection Policy
	The WTA Board endorses the use of the TFA Member Protection Policy. It relates to WTA's position on all behavioural matters of participants at WTA-controlled competitions. It is listed under the General Conditions of Entry and the respective Conditions of Entry for each competition.
N	Touch Football Australia Disciplinary Regulations Manual
	The WTA Board endorses the use of the Touch Football Australia Disciplinary Regulations Manual. All disciplinary matters will be managed in accordance with this manual.
O	Season
	Touch Football Australia has split the year into two (2) seasons. <ul style="list-style-type: none"> • Season 1 – 1st January to 30th June • Season 2 – 1st July to 31st December
P	20 Years and Under Player
	Players aged 20 or younger on the start of the competition are eligible to participate in an under-20 competition.
Q	Open's Player
	Players aged 13 or older on the year the competition commences are eligible to participate in a senior competition.
R	30 Years and Over Player
	Players aged 30 or older on the year the competition commences are eligible to participate in the 30-year-old competition.

S	35 Years and Over Player
	Players aged 35 or older on the year the competition commences are eligible to participate in the 35-year-old competition.
T	Junior Player
	<p>Players aged 14 or younger on the year the competition commences are eligible to participate in the Boys and Girls Junior competition.</p> <p>or</p> <p>Players aged 18 or younger on the year the competition commences are eligible to participate in the Mixed Junior competition.</p>

SECTION 2: AGREEMENTS

2.1	Agreements to enter Wagga Touch Association competitions
2.1.1	Abide by the WTA General Conditions of Entry, each relevant competition's Conditions of Entry documents and all WTA policies and by-laws.
2.1.2	Meet their financial obligation to the WTA, both as a Player/Team and for the competition entered, within the timelines outlined in the competition's Conditions of Entry.
2.1.3	Market the sport of Touch Football professionally and allow WTA to use the Affiliate's brand and reputation.
2.1.4	Attend all WTA functions where required. Non-attendance by mutual consent is acceptable.
2.1.5	Complete all competitive requirements of the WTA competition entered, including all finals and playoff matches, as outlined in the Conditions of Entry.
2.1.6	Ensure that all compliance matters required under the WTA Team Regulations have been met before entry into the competition.
2.1.7	Comply with any requirement outlined in the General Conditions or the Conditions of Entry documents for the provision of officials for the competitions entered.
2.1.8	Failure to comply with Clause 2.1.2 will result in the Team's inability to participate further in WTA competitions until all financial requirements are fulfilled.
2.1.9	Abide by any addendum or changes to competition conditions as applied by WTA due to changes in Public Health Orders.

SECTION 3: RESPONSIBILITIES

3.1	Players Responsibilities
3.1.1	Abide by the WTA General Conditions of Entry, each relevant competition Conditions of Entry document and all WTA policies and by-laws.
3.1.2	Complete a Membership and Participant Declaration through the WTA online player registration process, MySideline.
3.1.3	Always play to the best of your ability.
3.1.4	Always behave in a manner that does not bring WTA, the Team, or the Sport into disrepute as per WTA's Constitution and Member Protection Policy. Failure to comply with this clause may result in a penalty being imposed on the player.
3.1.5	Be available at all reasonable times for media and promotional purposes as requested by WTA.
3.1.6	If required to attend a function or media request related to WTA duties, they are to wear the official uniforms supplied by the Affiliate, NSWTF, and/or TFA, as requested by WTA.
3.1.7	Attend all WTA meetings/judiciary,/disciplinary hearing and requests as required.
3.1.8	Abide by the Member Protection Policy and Touch Football Australia Social Community Code as outlined in the General Conditions document.
3.1.9	To make themselves available as a first choice for WTA teams and NSWTF Regions. Failure to do so will deem the player ineligible for player status.
3.2	Team Responsibilities
3.2.1	To gain entry to a WTA competition, teams must respond within the required timelines as outlined in the Conditions of Entry for the competition they wish to nominate and comply with all the necessary requirements.
3.2.2	Ensure that all financial responsibilities for competition registration fees have been met.
3.2.3	Appointment of Team Coordinator and Duty Referee for the competitions entered. The Team Coordinator will serve as the primary liaison between the team and WTA on all matters, including refereeing duties.
3.2.4	Communication Each Team Coordinator MUST complete any required Microsoft Forms when entering a team. The link will be provided in each Competition's Conditions of Entry. All correspondence during the tournament will be sent out via the nominated email addresses. It is the Team Coordinator's responsibility to ensure that all provided email addresses are free of spelling errors. A request for a decision or ruling should be submitted in writing to the WTA.
3.2.5	Ensure that team players and Officials have been instructed on the Member Protection Policy and are aware of their responsibilities. Failure of the Team to comply with this clause may result in the Team being subject to a penalty.
3.2.6	Behave always in a manner that does not bring the WTA/Sport into disrepute.
3.2.7	Attend all relevant WTA meetings, judiciaries, disciplinary hearings, functions and media calls as required.

3.3	WTA Responsibilities
3.3.1	Plan and develop the Local Competitions Calendar, including leading and administering each WTA competition.
3.3.2	Promote Touch Football to their local community. Maintain a community-engaging domestic social touch football competition open to all potential participants. Regularly undertake activities to grow the said competition while upholding a high reputation and integrity.
3.3.3	To run a minimum of one (1) referee accreditation course per annum.
3.3.4	Ensure that all referees, coaches, and officials have met the minimum accreditation requirements for the competition they are entering, for their entry to be accepted.
3.3.5	Determine policy regarding financial matters affecting the competition, including: a. Centrally controlling income such as TV revenue, Major Corporate sponsors, naming rights, licensing, and sponsorship. b. Any penalty is to be imposed on the team.
3.3.6	Liaise with Wagga Wagga City Council, the governing body responsible for maintaining Jubilee Park, to ensure a standard playing surface, field markings, and facilities meet the requirements for WTA competitions.
3.3.7	Establish the systems for determining the winners at the end of the WTA competitions.
3.3.8	Keep teams and players informed about current trends and relevant information. Develop a process for teams and players to express their concerns and comments on any matter. The WTA must quantify its request for a decision or ruling in writing to the team or player.
3.3.9	Establish an effective program to prevent “stacking” of teams, ensuring a steady flow of players for all teams.
3.3.10	Determine the judicial procedures of the WTA competitions.
3.3.11	Abide by the Member Protection Policy and Social Media Policy.
3.3.12	Ensure match results are updated on the WTA Competitions.
3.4	Officials and Referees Responsibilities
3.4.1	Abide by the WTA General Conditions of Entry, each relevant Conditions of Entry document and all WTA policies and by-laws.
3.4.2	Officiate and always perform to the best of their ability.
3.4.3	Always behave in a manner that does not bring WTA, the Team/Affiliate, or the Sport into disrepute as per WTA’s constitution and Member Protection Policy. Failure to comply with this clause may cause the Official or Referee to be subject to a penalty.
3.4.4	Actively enforce and educate players on the zero-tolerance ‘no backchat’ policy towards referees.
3.4.5	Be available at all reasonable times for media and promotional purposes as requested by their team, affiliate, or WTA.
3.4.6	If required, when attending a function or media request related to WTA duties, wear the official uniforms supplied by the Team/Affiliate, WTA, NSWTF, and/or TFA as requested by WTA.
3.4.7	Abide by the Member Protection Policy and Social Media Policy.
3.4.8	All officials must have a minimum level of accreditation for the appointed position. Referees must wear the official referee uniform or a WTA-provided referee uniform.

3.4.9	Enforce all competition-specific clauses outlined in the Conditions of Entry relating to games, including the Mutual Respect Policy and procedure.
3.4.10	Complete all reports within the required timeframes.
3.4.11	Attend all relevant WTA meetings, judiciaries, disciplinary hearings, functions and media calls as required.
3.4.12	For the Team Coordinator and/or Duty Referee to liaise and cooperate with the WTA Referees Director and WTA Events Team, including weekend and weekly event appointments.
3.4.13	Referees must be registered and participating with WTA for eligibility and insurance purposes, and must regularly officiate at WTA in the current competition or a previous competition.

SECTION 4: COMPETITION, POOL, DIVISIONS AND CATEGORIES

4.1	Wagga Touch Association Competitions
4.1.1	Please check the relevant 'Conditions of Entry' for commencement dates, times and other relevant details.
4.1.2	<p><u>Monday Night</u> Men's 35 and Over Competition – Season 1 and 2 Competition This is a social competition for men aged 35 and older. It has modified rules – seven (7) a side, with the acting half not allowed to run. There will be three (3) pools within this competition.</p> <p><u>Tuesday Night</u> Men's and Women's Open Competition. (Pool C will be a Youth Competition 13 - 20 years old) - Season 1 and 2 Competition This is an open competition for men and women. It is ideal for social players. Pending team nominations, the men's and women's may have three (3) pools, if required.</p> <p>Men's and Women's Premier League – Season 2 Competition This is an open men's and women's competition for our elite players. This is WTA's showcase competition.</p> <p>Mixed Premier League – Season 1 Competition This is an open mixed competition for our elite players. This is WTA's showcase competition.</p> <p>Women's 30 and Over Competition – Season 2 Competition This is a social competition for men aged 30 and older. It has modified rules – seven (7) a side, with the acting half not allowed to run. If four (4) teams are not nominated in this competition, these teams will be moved to the lowest grade of women's open, but not to the competition formerly known as girls' youth league.</p> <p><u>Wednesday Night</u> Mixed Open Competition. Season 2 Competition This competition is a mixed competition. Teams are nominating for either a 6 pm or 7 pm time slot to play.</p> <p><u>Thursday Night</u> Boys' and Girls' Junior Competition. Season 2 Competition This competition is open to junior boys and girls in the following age categories: Under 8, Under 10, Under 12, and Under 14. Depending on the number of teams, there may be pools within each age group.</p> <p>Mixed Junior Competition. Season 1 Competition This competition is open to junior boys and girls participating in a mixed team in the following age categories: Under 8, Under 10, Under 12, Under 14, Under 16 and Under 18. Depending on the number of teams, there may be pools within each age group.</p>
4.1.3	This document contains information on Competitions, Pools, Divisions, and age requirements under the 'General Conditions of Entry' and in conjunction with the relevant 'Competition Conditions of Entry.'
4.1.4	At least four (4) teams must exist to create a competition, pool, division, or category. NB. The WTA Tournament Director will determine any variance on this and only in extenuating circumstances.
4.1.5	If fewer than four (4) teams are nominated, those teams will join the next closest competition, pool division, and/or category, as determined by the WTA Director of Tournament.

SECTION 5: ELIGIBILITY

5.1	Player Eligibility.
5.1.1	The onus to prove that a player is registered and participating in their competition is on the Team. Upon a protest or report, a Team found to be using a player that they cannot verify complies with this condition to the satisfaction of the WTA is liable to have the team and/or the player disqualified from the competition.
5.1.2	Upon request by a WTA Official, Tournament Official, Referee, or the Tournament Director, any player must be able to identify themselves for the purpose of verifying that they are a registered player for that team and competition. Failure or refusal to adequately identify themselves may result in the player being deemed ineligible for that match until their registration can be verified to the satisfaction of the WTA. Further sanctions may apply in accordance with these Conditions of Entry.
5.2	Competitions Player Eligibility.
5.2.1	Men's 35 Years and Over Competition.
5.2.1.1	Players must be born in 1991 or before. (35 years or older). (For competitions commencing that year in Season 1). Players must be born in 1991 or before. (35 years or older). (For competitions commencing that year in Season 2).
5.2.2	Men's and Women's Open Competition
5.2.2.1	Players must be born in 2013 or before (13 years or older). (For competitions commencing that year in Season 1). Players must be born in 2013 or before (13 years or older). (For competitions commencing that year in Season 2).
5.2.3	Men's and Women's Premier League
5.2.3.1	Players must be born in 2013 or before (13 years or older) (For competitions commencing that year in Season 2)
5.2.4	Women's 30 Years and Over Competition.
5.2.4.1	Players must be born in 1996 or before. (30 years or older). (For competitions commencing that year in Season 2).
5.2.5	Mixed Premier League
5.2.5.1	Players must be born in 2013 or before. (13 years or older) (For competitions commencing that year in Season 1).
5.2.6	20's Mixed Competition
5.2.6.1	Players must be born between 2006 and 2013. (13 years to 20 years of age). (For competitions commencing that year in Season 2).
5.2.7	Open Mixed Competition
5.2.7.1	Players must be born in 2013 or before. (13 years or older). (For competitions commencing that year in Season 2).
5.2.8	30's Mixed Competition
5.2.8.1	Players must be born in 1996 or before. (30 years or older). (For competitions commencing that year in Season 2).

5.2.9	Boys' and Girls' Junior Competition	
5.2.9.1	<p>Under 8's. Year of Birth 2019 or after Boys and Girls. Aged 5 if at school, 6 and 7.</p> <p>Under 12's. Year of Birth 2015/2016. Boys and Girls. Aged 10 and 11.</p>	<p>Under 10's Year of Birth 2017/2018 Boys and Girls. Aged 8 and 9.</p> <p>Under 14's Year of Birth 2013/2014 Boys and Girls. Aged 12 and 13.</p> <p style="text-align: center;">(For the Boys' and Girls ' Junior competitions commencing this current year in Season 2).</p>
5.2.10	Mixed Junior Competition	
5.2.10.1	<p>Under 8's. Year of Birth 2018 or after Boys and Girls. Aged 5 if at school, 6 and 7.</p> <p>Under 12's. Year of Birth 2014/2015. Boys and Girls. Aged 10 and 11.</p> <p>Under 16's. Year of Birth 2010/2011. Boys and Girls. Aged 14 and 15.</p>	<p>Under 10's Year of Birth 2016/2017 Boys and Girls. Aged 8 and 9.</p> <p>Under 14's Year of Birth 2012/2013 Boys and Girls. Aged 12 and 13.</p> <p>Under 18's Year of Birth 2008/2009 Boys and Girls. Aged 16 and 17.</p> <p style="text-align: center;">(For the Boys' and Girls ' Junior competitions commencing in the previous years in Season 2).</p>
5.3	Player Eligibility Exemptions	
5.3.1	Touch football is an inclusive sport. If you feel you have special requirements outside these Conditions of Entry, please send an email to contact@waggatouch.com.au . Each request will be evaluated on a case-by-case basis.	
5.4	Proof of Age	
5.4.1	<p>Team Coordinators for all age categories must have readily available proof of age for all players in their team. Only the following will be accepted as proof of age: a birth certificate, driver's licence, Passport, or Proof of age card.</p> <p>Teams using players without the required proof of age are liable to be disqualified if a protest is lodged and the player concerned cannot verify their age. Additionally, any player who cannot provide this identification will be disqualified from further competition until proof is provided.</p>	
5.5	Coaches & Managers Eligibility	
5.5.1	<p>Coaches and Managers must be current members and registered with WTA in the current competition.</p> <p>For competitions, the Coach should have a Coaching Accreditation. (If you are interested in obtaining this accreditation, please contact contact@waggatouch.com.au).</p>	

5.6	Referees and Duty Referees Eligibility
5.6.1	Kindly note that team nominations lacking the necessary referee nominations will not be accepted under any circumstances.
5.6.2	<p>Referees and Duty Referees are to be accredited.</p> <p>For competitions, the referee and or duty referee must have a Referee Accreditation. (If you are interested in obtaining this accreditation, please get in touch with contact@waggatouch.com.au).</p> <p>It is expected that all referees will meet the standards required to referee games at the WTA.</p>
5.6.3	Referees and Duty Referees must be registered for eligibility and insurance purposes and must regularly officiate for your team in the current competition.
5.6.4	<p>The team is responsible for ensuring that the referee or a duty referee is aware that the Team has nominated them. WTA may verify this during the registration process.</p> <p>During the verification process, if a referee or duty referee is unaware that the Team has nominated them, the Team will be advised. It may have to withdraw from the competition if a suitable replacement is nominated.</p>
5.6.5	<p>The minimum age for a referee at a senior competition and the mixed competition is fourteen (14) years old.</p> <p>The minimum age for a junior competition is twelve (12) years old.</p> <p>Any request for dispensation outside this clause needs to be in writing and endorsed by WTA.</p>

SECTION 6: TEAM REGISTRATION

6.1.1	<p>WTA uses the online team registration process via MySideline for all competitions.</p> <p>This online registration process is provided through MySideline and is accessible until the closing registration date. After this time, <u>no further registrations may be taken</u>. This is up to the discretion of the WTA Tournament Director.</p> <p>The link to register your team in the competition of your choosing can be found HERE.</p> <p style="text-align: center;">JUST A REMINDER, TEAMS CAN ONLY REGISTER A MAXIMUM OF 14 PLAYERS PER TEAM.</p>

SECTION 9: LATE ENTRY, LATE FEE ENTRY AND REFUNDS

At this time, any blood-stained clothing must also be either cleaned or replaced.</p> <p>If the player does not leave the field immediately, the Referee will stop the game and ask the player to leave the field (standard substitution rules apply).</p> <p>Once the flow of blood has been stemmed, the cut or abrasion has been cleaned and covered, and any blood-stained clothing and equipment have been cleaned or replaced, the player may return to the field and continue play. SECTION 11: PLAYING RULES AND SPECIAL PLAYING RULES

11.1	Playing Rules
11.1.1	<p>WTA conducts competitions under the Touch Football Australia 8th Edition rule book.</p> <p>WTA also includes variations of these rules, called Special Playing Rules, in the 'General Conditions of Entry' and the 'Competition Conditions of Entry.'</p>
11.2	Substitution and Interchange Area – (Except Under 8's and Under 10's)
11.2.1	<p>All interchanges must occur at or within the team's interchange area and only after the substituted player has crossed the boundaries and entered the Interchange area. All interchanges must be made on one side of the field and without delay.</p> <p>Physical contact is not necessary when players are interchanging. Players leaving or entering the field shall not hinder or obstruct play and must enter from an onside position. Following the scoring of a Try whilst the play is dead, players may interchange at will without having to wait for the substituted player to enter the interchange area.</p> <p>RULING (Rule 17) - A Penalty to the non-offending Team at the point of the Infringement.</p>
11.2.2	<p>The only personnel allowed in the interchange will be the fourteen (14) registered players plus four (4) team management officials nominated. That is a maximum of eighteen (18) people (this includes those players participating on the field).</p> <p>N.B Any player found to have left the sub box to become involved in a melee, brawl or fight may be dealt with in the following way. If, in the referee's view, a player/s or official/s leaving the sub box engages in illegal play that would, under the normal circumstances of general gameplay, warrant being sent off, they should do so. This will incur a minimum four (4) match suspension on top of any further suspension handed down by the judiciary.</p> <p>If, in the referees' view, a player/s or official/s leaving the sub box engages in <u>activities</u> that <u>would not</u>, under the normal circumstances of general gameplay, warrant being sent off, they should:</p> <ul style="list-style-type: none"> • Record the number of the player(s) leaving the sub box to become involved in a melee, brawl or fight. • Advise the captain that they will report those players to WTA. • File a report at the end of the game, noting those players for the WTA to take action. <p>Leaving the sub box to become involved in a melee, brawl, or fight will result in an automatic four (4) match suspension.</p>
11.3	Players, Coach and Referee Communication- Mutual Respect Policy
11.3.1	All members, whether Referees, Coaches, Players, Office Bearers, and/or spectators, have an obligation to be conversant with this protocol and the WTA, NSWTF, and TFA member Protection Policies. Please refer to the Mutual Respect Policy .
11.3.2	Referees are instructed not to engage with players, coaches, managers, or officials, to walk away from any possible confrontation, and to report it to the WTA.
11.3.3	Disputes of the score must be raised in writing with the Tournament Director.
11.3.4	All players need to be advised that Playing Rule 20, Misconduct, will remain in force. Referees have been instructed not to tolerate abusive behaviour in the Interchange Area during the game and to deal with it appropriately by removing a player from the field.
11.3.5	Players, coaches, managers, or officials may not agree with the way a referee officiates a game or with decisions made; however, there are proper procedures and avenues to handle such matters. Approaching referees after the game is not permitted. We do, however, welcome feedback, reports, or consultation under the proper guidelines.

	<p>Should you have an issue with the performance of a referee, you may:</p> <ul style="list-style-type: none"> • Contact either the Tournament Director or the Director of Referees. <p>If necessary, they will orchestrate a meeting with the referee, coach and panel member.</p> <p>Disputes or feedback must be submitted in writing and forwarded to the Tournament Director.</p>
11.3.6	<p>Breaches of the Mutual Respect Policy may incur a suspension, which will be imposed under the competition's control. Further, they may find themselves summoned to attend a judiciary, whereby the penalties may be imposed.</p>
11.3.7	<p>Coaching Positions</p> <p>The only people allowed behind the deadball line are the Coach, Assistant Coach, or Manager. A Coach may position themselves at the end of a field. If they are at the end of the field, they must remain at least five metres behind the deadball line.</p> <p>Any Coaching/Management staff at the end of a playing field cannot issue any verbal or physical commands directly to the team they are observing and can only communicate to the team or other coaching/management staff in the interchange area by returning to the interchange area or by use of electronic communication equipment. Any person found to be disregarding this tournament rule will be asked to return to the interchange area. Coaches are reminded that they are under the jurisdiction of the Tournament Conditions, WTA Officials and the referees, regardless of whether they are in the interchange area or at the end of the field.</p> <p>Failure to comply with this will result in individuals being asked to leave the venue for the duration of the game and may result in further action.</p>
11.4	Captain Bands
11.4.1	<p>WTA is continuing its “zero tolerance” policy toward referees to ensure referees remain engaged in our game.</p>
11.4.2	<p>Each team will be given an armband, which one player (the captain) will wear throughout the game.</p>
11.4.3	<p>Only the player (the captain) with the armband will be allowed to speak to the Referee, and this must be done with respect.</p>
11.4.4	<p>If other players distract the Referees by giving them their opinion, speaking to them unnecessarily, questioning calls, etc., the player will automatically be penalised and sent to “the bin”.</p>
11.5	Send Offs
11.5.1	<p>Any player sent from the field for the remainder of the game will receive an automatic two (2) match suspension.</p> <p>Players sent off for the remainder of the game, and judicial matters will be handled in accordance with the Touch Football Australia Disciplinary Regulations Manual.</p>
11.5.2	<p>Matches not played or cancelled due to weather will NOT be included in that suspension.</p>
11.6	Sin Bins
11.6.1	<p>Players who receive two ‘sin bins’ throughout the competition will receive an Automatic one (1) match suspension. Every subsequent sin bin will receive an automatic one (1) match suspension.</p>
11.6.2	<p>A one (1) or two (2) match suspension is to be served on the following:</p> <ul style="list-style-type: none"> - one (1) or two (2) games in which the team is scheduled to play. - Byes do not count as a game played. - A team that wins by a forfeit will count; however, a team losing by a forfeit will not.
11.6.3	<p>A sin bin applied to a player for a team offence will not be registered against an individual.</p>

11.7	Special Playing Rules
11.7.1	Men's 35 and Women's 30 Competition
11.7.1.1	All competitions/pools will play seven (7) a side.
11.7.1.2	There is no running from acting half in this competition. There will be a change of possession if the referee deems that the acting half has taken too many steps from the acting half.
11.7.2	Boys', Girls' and Mixed Junior Competition
11.7.2.1	Under 8's and Under 10's will play five (5) a side.
11.7.2.2	Under 8's and Under 10's will play on half (½) a field.
11.7.2.3	Under 8's and Under 10's coaches are allowed on the field to coach their players if they wish, but it is not compulsory. Coaches MUST always stand behind their own team. If coaches interfere with play in any way, they will be asked to leave the field. <i>Coaches MUST also wear closed shoes (thongs are not allowed).</i>
11.7.2.4	Under 8's acting half CANNOT run with the ball.
11.7.2.5	Under 8's defending team cannot move up until the first receiver takes possession of the ball.
11.7.2.6	All players must play in their own age group as per 5.2 and 5.3.
11.7.3	Boys' and Girls' Junior Representative Player Rule
11.7.3.1	<p>A team may not have more than three (3) representative players registered in a team of that age group.</p> <p>Representative players include players who represented at the previous year's Junior State Cup in the Blue team at the Southern Conference, NSW Junior Regional Championships, or other Representative Teams within NSW Touch and any player who represented at the school level in a team, including CCC, CHS, & in the previous year.</p> <p><i>This Rule applies to the Thursday Boys' and Girls' Junior Competition, not the Mixed Junior Competition.</i></p>
11.7.3.2	<p>Playing Up Exemption</p> <p>A team may register one (1) representative player of the age group directly below the age group the team is registering into. This player can be in addition to the three (3) representative players in 11.7.3.1.</p> <p>Representative players include players who represented at the previous year's Junior State Cup in the Blue team at the Southern Conference, NSW Junior Regional Championships, or other Representative Teams within NSW Touch and any player who represented at the school level in a team, including CCC, CHS, & in the previous year.</p> <p><i>This Rule applies to the Thursday Boys' and Girls' Junior Competition, not the Mixed Junior Competition.</i></p>
11.7.3.3	<p>Home Grown Exemption</p> <p>A team may apply to register up to five (5) representative players who have played in that team for the immediately preceding three (3) or more seasons. That is, an additional two (2) representative players from Rule 11.7.3.1.</p> <p>Should one or more of the representative players leave the team, they cannot be replaced by another representative player (s) in anticipation of remaining exempt from the Junior Representative Player Rule under this exemption.</p> <p>Requests made under this exemption must be made in good faith.</p> <p>Representative players include players who represented at the previous year's Junior State Cup in the Blue team at the Southern Conference, NSW Junior Regional Championships, or other Representative Teams within NSW Touch and any player who represented at the school level in a team, including CCC, CHS, & in the previous year.</p>

	<i>This Rule applies to the Thursday Boys' and Girls' Junior Competition, not the Mixed Junior Competition.</i>		
11.7.3.4	<p>Limitations of Exemptions.</p> <p>If you are seeking to use one of the exemptions to the Junior Representative Player Rule, this request must be made in writing to juniors@waggatouch.com.au two (2) weeks before the commencement of the Junior Competition for approval by the WTA Board.</p> <p>Teams may only apply for one (1) exemption per season.</p>		
11.7.4	Wagga Junior Viper Representative Teams		
11.7.4.1	Any player who wishes to try out and play for Wagga Vipers U8's to U14's Representative team must be registered and play in the season 2 of the Wagga Junior Competition in their own age group, as per Section 5.2.9.		
11.7.4.2	Any player who wishes to try out and play for Wagga Vipers U16's or U18's Representative team must be registered and play in the season 2 of either the Wagga Men's and Women's Opens competition or Wagga Men's and Women's Premier League.		
11.7.5	Reserve Grade Rule		
11.7.5.1	<p>The Reserve Grade Rule is introduced to help prevent forfeits and deferred matches, and, most importantly, to promote player development. This rule is only to be used if teams are short on players.</p> <p>This rule is NOT for resting available players and bringing up reserve-grade players.</p>		
11.7.5.2	<p>A team may invite a maximum of two (2) players per game from a competition, division, or pool lower than the grade the team are currently playing in, and these players will be known as 'Reserve Grade Players'. The WTA competition rankings are listed below.</p> <p>A reserve grade player may only play for the same team twice throughout the season. SECTION 12: PROTEST, DISPUTES AND DISCIPLINE

12.1.1	<p>Protest and dispute matters will be heard and determined by either the Tournament Director or, if required, the WTA Judiciary Panel appointed by the WTA officials.</p> <p>Players sent off for the remainder of the game, and judicial matters will be handled in accordance with the Touch Football Australia Disciplinary Regulations Manual.</p>
12.1.2	<p>Protests and/or disputes must be lodged in writing to the WTA Tournament Director within 24 hours of the conclusion of the competition.</p>
12.1.3	<p>Protest is to be lodged via email and signed by the team coordinator.</p>
12.1.4	<p>WTA's delegated authority will then investigate protests, and their decision will be returned to the team coordinator.</p> <p>Any notice to any person to attend a hearing must be served on the team coordinator, and such service is deemed to be served on all parties or persons under the team coordinator's control.</p>
12.1.5	<p>WTA reminds all parties that the following issues will not be open to appeal and/or protest and, therefore, formally advises all teams that they must be aware of this prior to the commencement of games:</p> <ul style="list-style-type: none"> • The Referee is the sole judge on all match-related matters inside the field perimeter for the duration of a match, and they have jurisdiction over all players, coaches, and officials.
12.1.6	<p>If a team disagrees with the score on the scorecard, they are to lodge a protest.</p> <p>The following information is to be provided with the protest:</p> <ul style="list-style-type: none"> • Who tapped off • The order in which the scoring occurred (including player numbers of both teams) • The half-time and full-time score <p>The opposing team will be contacted to verify the score. If they do not agree or in the event of inconclusive evidence, the score will be recorded as the score that the Referees have recorded.</p> <p>Alternatively, video evidence can be provided, and the evidence will be used if conclusive.</p>
12.1.7	<p>Players sent from the field for the remainder of the game will be dealt with in accordance with the Touch Football Australia Disciplinary Regulations Manual. They may be required to appear before a WTA Judiciary or Disciplinary Hearing. The Touch Football Australia Disciplinary Regulations Manual allows for the individual to accept the penalty early rather than appear before a Judiciary Hearing.</p>
12.1.8	<p>Any Player, Official or other Member of a Team/Affiliate who is the subject of a complaint or report may be dealt with in accordance with the Touch Football Australia Disciplinary Regulations Manual and may be required to appear before a WTA Judiciary or Disciplinary Hearing.</p>
12.1.9	<p>Disciplinary Hearings will be conducted at the earliest possible opportunity after the report is handed to the player and team coordinator.</p> <p>If a complaint or report is submitted about a player, official, or other member, the WTA official will contact the player and the team coordinator, who will be issued a Notice of Hearing outlining the details of the Disciplinary Hearing and a copy of the written complaint or report.</p> <p>Judiciary hearings within WTA will take place on Thursday nights from 7:00 pm.</p>
12.1.11	<p>WTA has adopted Touch Football Australia (TFA) Code of Conduct and the TFA Social Media Community Code. Players, teams, officials, guardians, and spectators must abide by these codes, available by clicking the links above. If a Wagga Touch Representative suspects that anyone has breached these</p>

	<p>codes, they may be asked to leave the Touch Fields. Failure to do so will result in the game being stopped or cancelled until the offending person complies.</p>

SECTION 13: UNIFORMS

13.1	Quality
13.1.1	<p>All teams playing uniforms are to be correctly numbered, have the same design and artwork, and be correctly worn for all games of the competition. Approved Touch Football shoes must be worn in accordance with Rule 3.2 of the TFA rulebook. N.B. Uniform designs that clash with the Referee Uniform will NOT be allowed (to avoid confusion with the Referee).</p> <p>Ideally, WTA would like to see our logo on the right-hand side of the chest. The WTA logo can be found by clicking on this LINK.</p> <p>Official playing uniform items are determined as (but not limited to):</p> <ul style="list-style-type: none"> • Playing Shirt or Singlet. • Playing Shorts or Tights. • Socks. <p>All playing uniforms must include the following:</p> <ul style="list-style-type: none"> • Identification numbers: All players are to wear an identifying number on the back of their shirt/singlet. • No temporary measures, such as tape, will be permitted to replace or amend numbers. • A one or two-digit number that meets the requirements set out above. • The only playing numbers permissible are from 1 to 16 inclusive.
13.1.2	<p>If a Player, Coach, Manager, or Team Official is observed by a Tournament Official or the Tournament Director to be wearing an incorrect team uniform while participating in a match, they will be directed to leave the field of play. They may not return until they are correctly attired in the approved team uniform.</p> <p>The following penalties apply if a Player, Coach, Manager, or Team Official takes the field of play in an incorrect team uniform:</p> <ol style="list-style-type: none"> 1. If the team wins the match while rostered on for duty, four (4) competition points will be deducted. 2. If the team loses the match while rostered on for duty, two (2) competition points will be deducted.
13.1.3	<p>Teams are to be correctly attired by Round 4. If teams are having supplier issues, please communicate this before the start of Round 5. Please email contact@waggatouch.com.au</p>

SECTION 14: SPONSORSHIP AND LOGO DISPLAY

14.1	Affiliate Uniforms
14.1.1	All logos and sponsor names on uniforms or dress gear must be of a size, quality, and design standard acceptable under the NSWTF Uniform Guidelines .
14.2	Other Usage of Logos & Banners
14.2.1	<p>Use of the WTA and WTA Sponsors is encouraged; however, any use must be authorised by WTA.</p> <p>Any public display of an Affiliates Sponsors logo and or their partners must receive express permission from the WTA prior to the competition.</p> <p>Penalty: \$500 maximum per breach.</p> <p>N.B Sponsors and or partners that directly conflict with WTA partners at WTA competitions will not be granted display permissions.</p>

SECTION 15: IMAGES

15.1.1	All persons accept that by participating in their selected competition, they may be photographed/filmed and that the WTA may use these images for the promotion of the sport. The WTA will not pass any image (s) to a third party unless prior approval is obtained. If you do not wish the WTA to be able to use your image/s or be filmed, you must notify the WTA in writing.
15.1.2	WTA reserves the right to take immediate possession of any video footage taken at a WTA competition that may assist the WTA in investigating any matter of judicial, disciplinary, or protest. All care of equipment, tape, and data cards will be taken and returned to the owner upon a determination by the judiciary, disciplinary hearing, or protest.
15.1.3	<p>With the rise in social media use, WTA has regulations (adopting the TFA & NSWTF policy) regarding the filming and/or photography of players and games at competitions. To protect privacy and images, anyone filming or photographing games or players must be registered with and APPROVED by WTA to photograph or film. By allowing photography/videography, applicants must comply with the relevant clauses and conditions set out by the WTA regarding the use of the footage/photos.</p> <p>Teams must apply to the WTA prior to the competition for any official photographer/videographer and acknowledge, along with the approved applicant, that images/film MUST NOT be passed on to a third party unless prior approval is sought and granted.</p> <p>Approved applicants must report to the Tournament Director prior to the commencement of the competition to be issued a WTA Official photographer vest and/or pass that must be worn or displayed at all times while engaged at the competition/event. Non-compliance will result in the immediate removal of credentials and permissions.</p>

SECTION 16: WORKING WITH CHILDREN

16.1	Working with Children Check (WWCC)
16.1.1	<p>Working With Children Check (WWCC) is a legal requirement for persons who work or volunteer with children (under 18 years old). It checks the background of persons who work or volunteer with children in sports clubs, schools, childcare centres, community groups, Churches, and other organisations.</p> <p>All coaches and managers of teams with players under the age of 18 registered must have a WWCC and provide the WTA with the details accordingly.</p>
16.2	Guardianship
16.2.1	<p>In some instances, persons under the age of 18 will be in attendance at WTA competitions. In understanding our expectations around your role and responsibilities, we provide Teams with some additional information related to legal guardianship. This communication contains general advice only and does not take into account individual objectives, circumstances and or a legal view. Individual research and advice should be sorted according to your personal circumstances.</p> <p>Guardians - A guardianship is a legal right given to a person to be responsible for the food, health care, housing, and other necessities of a person deemed fully or partially incapable of providing these necessities for himself or herself.</p> <p>What Are a Guardian's Duties? The guardian makes decisions about how the person lives, including their residence, health care, food, and social activity. The guardian is intended to monitor the person and ensure that the person lives in the most appropriate, least restrictive environment possible, with appropriate food, clothing, social opportunities, and medical care.</p> <p>Communication with the Parents Ensure you are informed of any medical concerns, including food allergies. In addition, you'll need to agree on things like sleeping arrangements, the administration of over-the-counter medications, and procedures for contacting the parents in an emergency.</p> <p>Information provided and acknowledged from the following websites: http://www.expertlaw.com/library/estate_planning/guardianship.html https://www.verywellfamily.com/temporary-guardianship-forms-2997661</p>
16.3	Supervision of Under Age Participants
16.3.1	<p>Teams are responsible for the direct supervision of any player, official or referee who is under the age of 18 years old ("Minor"). Teams must take all reasonable steps to protect Minors under their supervision from all forms of harassment. This includes but is not limited to ensuring that:</p> <ul style="list-style-type: none"> • Each Minor and their legal guardian are provided with a copy of the Member Protection Policy; • All Officials comply with all applicable Child Protection laws. <p>All reasonable steps are taken to supervise Minors when travelling to, during, and from the Competition. The Team must appoint a guardian for each Minor whose parents and/or legal guardian are not in attendance. The appointment of such guardian must be approved in writing by the parents and/or legal guardians of the Minor prior to the Competition.</p>

SECTION 17: BREACHES OF RESPONSIBILITY

17.1.1

In the event that a participant or team breaches any responsibility as set down in the General Conditions of Entry or the Conditions of Entry documents, that participant or team will be required to explain the Breach to a duly convened meeting of the Board or their representative, the Tournament Director.

In accordance with the WTA Constitution, the penalty that may be applied through the power hereby conferred may disqualify, suspend, fine or otherwise deal with any person or body they find to have been guilty of such Breach.

Any rule breach not mentioned in this document will be subject to a penalty as determined by the Board or their representative, the Tournament Director.

Any appeal against the determinations of the Board or their representative, the Tournament Director, must be lodged with an appeal fee of \$200.00. The fee will be refundable upon the appeal being upheld.

SECTION 18: DOPING POLICY

18.1.1

The WTA is under the TFA Doping Policy, which will be enforced at WTA competitions. The Australian Sports Anti-Doping Authority (ASADA) could randomly test any participant (in accordance with their policy). Any indiscretions found will incur the penalties as prescribed in the TFA Doping Policy. This information can be obtained from the TFA Website.

SECTION 19: POLICIES

Item 1: Member Protection Policies

Member Protection is a significant issue both within the community and within the sports environment. WTA has a moral responsibility to ensure we remain valid and current with Member Protection issues related to the members of WTA.

TFA and NSWTF have adopted an education process on the issue of 'Play by the Rules'. This program is available at www.playbytherules.net.au. It has several interactive courses that coaches and officials can take to learn more about Member Protection. Below is the statement from the home page of the Play by the Rules website.

"Play by the Rules" provides information and online learning about how to prevent and deal with discrimination, harassment and child abuse in the sport and recreation industry.

"Play by the Rules" is a partnership between the Australian Sports Commission and all State/Territory sport and recreation and anti-discrimination agencies. The information on Play by the Rules is not intended to be, nor should it be relied upon as, a substitute for legal or other professional advice."

WTA will encourage each official attending WTA competitions to complete the online course and supply their team with a certificate for completing the course. The course is relatively easy and informative and takes limited time to complete. The certificate should be submitted via email to contact@waggatouch.com.au. We hope that you find value in this initiative as we all work towards providing an environment that is both positive and safe for all participants.
