Pending team nominations, the men's and women's may have three (3) pools, if required.</p> <p>Twelve (12) round competition with a three (3) week finals series.</p>

D	Compulsory Men's and Women's Open Competition Meeting.
	<p>A compulsory meeting for all Men's and Women's Open teams will be held at the <b>Jubilee Park Clubroom on Tuesday, 11<sup>th</sup> August 2026.</b></p> <p><b>Meeting Schedule:</b></p> <ul style="list-style-type: none"> <li>• Women's Open teams must attend the <b>6:00 PM session.</b></li> <li>• Men's Open teams must attend the <b>6:45 PM session.</b></li> </ul> <p><b>Attendance is mandatory</b> – only one (1) representative from each team must attend this meeting in order for the team to be included in the competition draw. This representative can be any registered player competing in a nominated Men's or Women's open team.</p> <p>Each meeting is expected to run for no longer than <b>30 minutes.</b></p>

<b>E</b>	<b>Player Eligibility.</b>
	<p>All conditions of player eligibility must be complied with in accordance with <b>Section 5 of the WTA General Conditions of Entry.</b></p> <p>WTA General Conditions of Entry Section 5.2.2.1. Players must be born in 2013 or before (13 years or older). <i>(For competitions commencing that year in Season 2).</i></p>
<b>F</b>	<b>Team Registration.</b>
	<p>All Conditions of Entry must be complied with in accordance with <b>Section 6 of the WTA General Conditions of Entry.</b></p> <p>To nominate your team for your selected competition, please complete the Team Nomination Form by clicking <a href="#">HERE</a>.</p> <p>Once your team nomination has been submitted, please click <a href="#">HERE</a>. to nominate your team's Duty Referee, as required under Section 8 of the WTA General Conditions of Entry. Failure to nominate a Duty Referee by the team nomination closing date may result in your team being ineligible to participate in the competition until this requirement has been met.</p> <p>Please also confirm with your nominated Duty Referee that a copy of their current referee accreditation certificate has been provided to the WTA Tournament Director. If it has not, please email a copy of the accreditation certificate to <a href="mailto:tournaments@waggatouch.com.au">tournaments@waggatouch.com.au</a>.</p> <p>Team Coordinators/Managers are reminded that a minimum of ten (10) registered players is required by the team nomination closing date, in accordance with <b>Section 6.1.3 of the WTA General Conditions of Entry.</b></p> <p style="text-align: center;"><b>Please note that teams may register a maximum of fourteen (14) players per team.</b></p>
<b>G</b>	<b>Player Registration, Membership and Competition Fees.</b>
	<p>All player registration conditions must be complied with in accordance with <b>Section 7 of the WTA General Conditions of Entry.</b></p> <p>Your team coordinator/manager can email you a team invitation to register as a player. If not, you can register by clicking <a href="#">HERE</a>. You will need to know your team's name.</p> <p><b>COMPETITION FEE FOR THIS SEASON: - \$70.00 inc GST.</b></p> <p><i><b>Just a reminder:</b> players registering and paying the competition fee after the team nominations closure date will incur a \$20 late fee. As per the WTA General Conditions of Entry, Section 9.1.4.</i></p> <p><b>Please Note:</b> As per the WTA General Conditions of Entry, Sections 7.2, 7.3 and 7.4.</p> <p>7.2.1. - WTA annual membership fee of <b>\$2.00</b>. This membership fee is in accordance with the <i>Constitution of the Wagga Wagga Touch Association Incorporated</i>, Part 2 – Membership, clause 9.1: Fees and Subscriptions.</p> <p>7.3.1. - TFA National membership fee of <b>\$30.00</b>. NSWTF state membership fee of <b>\$30.00</b>.</p> <p>7.4.1. - Wagga Wagga City Council ground fee.</p> <ul style="list-style-type: none"> <li>• <b>\$44.00</b> for senior players</li> <li>• <b>\$35.00</b> for junior players</li> </ul> <p><i>Once you have paid your annual membership fees, you can register in as many competitions as you would like. The membership expires on 30 June each year.</i></p>

<b>H</b>	<b>Duty Referee.</b>
	<p>All teams are required to nominate and provide a duty referee when rostered. The team-nominated duty referee or duty referees will be appointed for one (1) game per rostered duty team. (WTA suggest a team should have two (2) duty referees attend to share the game).</p> <p>Duty referees will be paid \$30 per game and will receive payment on the night of the game.</p> <p>Failure to supply a duty referee will result in the following: -</p> <ol style="list-style-type: none"> <li>1. If the team wins that match when rostered on for duty, they will lose four (4) competition points.</li> <li>2. If the team loses that match when rostered on for duty, they will lose two (2) competition points.</li> </ol> <p>Teams that fail to supply a duty referee may also face further action as determined by the WTA Board.</p>
<b>I</b>	<b>Wagga Junior Viper Representative Teams.</b>
	<p>Any player who wishes to try out and play for Wagga Vipers U16's or U18's Representative team must be registered and play in the season 2 of either the Wagga Men's and Women's Opens competition or Wagga Men's and Women's Premier League.</p>
